#### **KMXT Code of Conduct**

The following is a Code of Conduct for the KMXT community. This Code was drafted with input from KMXT staff, KMXT Board of Directors, CAB members, and volunteers.

- 1. Treat other people as you would like to be treated yourself.
- 2. Care will be taken with KMXT property, and it will be returned in the same or better condition as when it was received.
- 3. All KMXT personnel have a responsibility to support a fair workplace that provides equal opportunity and promotes an environment where all KMXT personnel can reach their full potential and maximize their contributions to the KMXT Mission.
- 4. The General Manager is responsible for overseeing all matters relating to the operation of the station.
- 5. Staff, volunteers, visitors and guests will follow the rules and regulations of the station as stated in the Staff Handbook and Volunteer Handbook, and obey all applicable laws.
- 6. Verbal and physical attacks are not tolerated on KMXT property, or at KMXT events and meetings.
- 7. Discussions will be centered on issues, not people; and on verifiable facts, not innuendo and rumor. This covers oral and written statements made anywhere, including on the Internet.
- 8. Information will be shared as much as possible, keeping in mind that some information must remain confidential. If information has been designated as confidential, it will not be divulged either publicly or privately.
- 9. Violation of this code will result in a penalty, which may include exclusion from KMXT property and events.
- 10. Disputed charges of violation of this code will be brought before a mediator for a final and binding decision. Anyone wishing to file a complaint may do so on a form available at the reception desk in the station.
